SPECIAL CODE NOTICE **To: All New Castle City Residents and Property Owners RE: Removal of Snow or Ice from Sidewalks and Trails**

In the aftermath of the recent January 23, 2016 snow event, many of our Citizens complied with the City Code and cleaned/ cleared the sidewalks adjacent to their properties, and for that we thank you. However there were also a large proportion of properties that failed to comply,



and consequently, contributed to the hazardous conditions that existed well after the storm.

The City Code states: **Chapter 209. Streets and Sidewalks Article I. Removal of Snow and Ice** [Adopted 4-1-1986 by Ord. No. 279] § 209-1. Removal of snow and ice required.

Any person, corporation, company or other entity, being Thank you for your cooperation and consideration in the owner, tenant or occupant of any house or other building, or the owner of any improved or unimproved lot, shall remove any snow, hail, ice or other matter or thing from any pavement, sidewalk or footway along and adjoining said premises within 24 hours of the time snow ceased to fall or the ice formed. Said owner, tenant or occupant shall cause a pathway to be *cleared* at least three feet in width along the pavement or sidewalk to the gutter to allow the free passage of pedestrians.

Chapter 140. Housing and Property Maintenance

Article III. Administration and Enforcement § 140-13. Action by City upon failure to correct.

In the event the owner, occupant, or tenant fails to comply with the lawful order of the Code Enforcement Officer to make safe or correct a dangerous or unsafe condition ... the Code Enforcement Officer shall proceed, when in his or her opinion emergency action is required, to abate the unsafe condition by appropriate means. All costs incurred by the City for the abatement of such conditions shall be paid by the owner or possessor of the land in procedures established in this code. In addition to any expense incurred by the City for the removal or abatement of such violations, an administrative fee shall be assessed to the owner or possessor of land or improved premises. Such administrative fee shall be set from time to time by resolution of the City Council.

§140-14. Collection of fees: creation of tax lien.

Any expense of removal or abatement by the City in the enforcement of this code shall be

All sidewalks adjacent to each property must be cleared.

It should be noted that curb cuts and intersections where sidewalks meet streets there should be a clear path; additionally, for everyone's safety, fire hydrants should also be cleared as soon as possible.
